



Subject: Amendment In the Flag Code of India, 2002- Reg.

The use/display/hoisting of the Indian National Flag is governed by the Prevention of Insults to National Honour Act, 1971 and the Flag Code of India, 2002, which are available on this Ministry's website www.mha.gov.in. With the approval of the Competent Authority, clause (xi) of paragraph 2.2 of Part-II of the Flag Code of India, 2002 has been amended and it shall be read as under:-

“(xi) where the Flag is displayed in open or displayed on the house of a member of public, it may be flown day and night;”
