

- ii. governed by "New pension scheme" (NPS) as per SRO-400 of 2009 dt:-24-12-2009.
- iii. subject to verification of all the required documents from concerned quarters.
- iv. Cancelled, if at any stage, documents/ information submitted proved to be fake / fabricated, and action as warranted under rules shall be initiated against her.
